**NOTICE OF TRUSTEE'S SALE**

West along the West line of said 88.047 acre tract, the East line of said 134.187 acre tract, and generally with a fence, a distance of 277.52 feet to a 1/2" iron rod set for the Northwest corner of herein described tract; THENCE North 59 deg. 26 min. 13 sec. 
